Article V, Section 2, Directors-at-Large, of the TCTA Bylaws states:

- B. Qualifications.
 - 1. Qualifications shall be the same as for District Directors.
 - 2. No two (2) Directors-at-Large may serve from the same local CTA unit concurrently as long as there is more than one local association in a district.
 - 3. A person shall be ineligible to run for a Director-at-Large position if election would extend tenure in office beyond five (5) consecutive years as a member of the Directors' Council. Years served as a District Director shall be included in the five-year limitation.

C. Term of Office.

- 1. Directors-at-Large shall serve a term of one (1) year.
- 2. Directors-at-Large shall assume office on June 1 following election.
